Rating Rationale

Acuite has downgraded and withdrawn its long-term rating to 'ACUITE BB-' (read as ACUITE Double B Minus) from 'ACUITE BB' (read as ACUITE Double B) and reaffirmed the short-term rating of 'ACUITE A4+' (read as ACUITE A Four Plus) on Rs.13.13 Cr. bank facilities of Advance Die Cast. The rating has been withdrawn on account of the request received from the company and the NOC (No Objection Certificate) received from the banker.

Acuite has also withdrawn its rating on the proposed long-term and short-term bank facilities of Rs.1.22 Cr. of Advance Die Cast without assigning any rating as it is a proposed facility. The rating has been withdrawn on account of the request received from the company.

The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information. The rating is downgraded on account of information risk.

The rating has been withdrawn as per Acuite's policy of withdrawal of ratings as applicable to the respective instrument/facility.

About the Company

Incorporated in 1994, Karnataka based, Advance Die Cast (ADC) is a partnership firm engaged in the manufacturing of die cast components and fabricated motor parts used for industrial purpose. The firm is promoted by four partners, Mr. Sivaram Hegde, Mr. Nagaraj Divite, Veena S Hegde and Bharati N Divite.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non co-operation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuité’s

policies.

This rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower) . Acuite endeavoured to gather information about the entity/industry from the public domain.
