Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE Bf) from 'ACUITE B+' (read as ACUITE B plus) on the Rs. 8.75 crore bank facilities of Ratan Textiles Private Limited (RTPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Jaipur-based, Ratan Textiles Private Limited (RTPL) was established in 1985 by Jain family. RTPL manufactures and exports made-ups, including home furnishing products, and readymade garments for ladies and kids. RTPL exports to USA, Japan, UK, Australia, to name a few. The Current Directors of the company are Mr Naresh Kumar Jain and Mr Sunit Kumar Jain.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Limitation regarding information availability

Acuite endeavoured to gather information about the entity/industry from the public domain.
