Rating Rationale

Acuité has downgraded the long-term rating to '**ACUITE B-**' (read as **ACUITE B minus**) from '**ACUITE B**' (read as **ACUITE B**) on the Rs. 6.44 crore bank facilities of Samyak Creations Private Limited (SCPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

About the Company

Varanasi-based, Samyak creations Private Limited (SCPL) was incorporated in 2014, by Mr. Amit Poddar, Mrs. Abhilasha Poddar, Mr. Ravi Kant Poddar and Mrs. Meera Poddar. The company is engaged in embroidery work, fringes and laces. Further, SCPL has an installed capacity of embroidering 135000 sarees per annum. The capacity utilization as on 31st March, 2019 stood at 92 per cent.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
