Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE D' (read as ACUITE D) on the Rs. 75.00 crore bank facilities of Pannageshwar Sugar Mills Limited (PSML). The rating continues to be flagged as "Issuer NotCooperating" and is based on the best available information.

About the Company

Latur based Pannageshwar Sugar Mills Limited (PSML) was incorporated in 1999. The company is promoted by Mrs. Pradnyatai Gopinathrao Munde - Chairman & MD. PSML is engaged in the manufacturing of sugar and other byproducts of sugar cane with a capacity of 2000 tonnes crushed per day (TCD).

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
