Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B**' (read as **ACUITE B**) from '**ACUITE B+**' (read as **ACUITE B plus**) and reaffirmed the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 8.50 crore bank facilities of Towels Enterprises Limited (TEL). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

About the Company

Ludhiana based Towels Enterprises Limited (TEL) was incorporated on 7 May 2015 by Mr. Ajay Latawa and Mr. Sumit Gupta. It was originally started as a proprietorship. The company is engaged in the trading of terry towels, bedsheets, coal, rice husk, chemicals such as acetic acid, toluene, sodium metal and sodium dichromate. TEL imports from USA and China and exports mainly to South Africa.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
