Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B+' (read as ACUITE B plus) from 'ACUITE BB-' (read as ACUITE double B Minus) on the Rs.14.00 crore bank facilities of Vijay Automobiles (VA) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Alwar-based, Vijay Automobiles (VA) was established in 1972 by the Late Mr. Jagdhish Prasad Agarwal and Mr. Vijay Agarwal. Mr. Vijay Agarwal is still associated with the firm. The firm is engaged in the trading of automobile ancillary parts of commercial vehicles in Alwar, Jaipur, Kota, and Bikaner areas of Rajasthan. Vijay Automobiles is an authorised dealer of Tata Motors Automobile ancillary parts and currently, it has acquired a new business from Tata Motors for the supply of vehicles on road spare parts.
