Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 9.00 crore bank facilities of Moogambigai Metal Refineries. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Karnataka based - Moogambigai Metal Refineries (MMR) was established in the year 2010 as a partnership firm. The firm is a part of the JC group, and is engaged in the business of recycling of plastic and electronic waste items. Initially, the firm was engaged in the business of aluminium smelting, and as the industry is not so favourable, switched over to e-waste and plastic recycling. MMR is promoted by Mr. A. Harisudhan, Mr. P. Anbalagan, Mr. P. Arumugam, Mr. A. Sabarinathan, Mr. Nithin Arumugam, Mr. C. Pradeep, Mr. P. Chandrasekharan, Mr. P. Ramalingam, Mr. C. Prasath and Mr. C. Bharanikumar.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/ borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower).
