Rating Rationale

Acuité has downgraded the long term rating to 'ACUITE B-' (read as ACUITE B minus) from 'ACUITE B' (read as ACUITE B) and reaffirmed the short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs.15.00 crore bank facilities of Add Technologies India Limited (ATIL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Bengaluru based, Add Technologies India Limited was incorporated in the year 1995 and started commercial operations from 2006 as an engineering and technology expertise organization. Add Technologies India Limited currently provides Any Time Payment (ATP) services majorly to electricity boards and banks. It also provides GPS Safety products and solutions. The company has a presence in about seven states comprising Karnataka, Maharashtra, Gujarat, Madhya Pradesh, Chhattisgarh and West Bengal. The present directors of the company are Mr. Anil Kumar Sethi, Mr. Srinivasa Sundarajaiyengar Kallahalli, Mr. Prithvi Gururajarao and Mr. William D'Souza.
