Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs.6.00 Crore bank facilities of R Selvaraj on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

R Selvaraj (RS) is a Salem-based proprietorship firm established in 1990 by Mr. R Selvaraj. The firm is engaged in the execution of civil contracting works such as buildings, bridges, petrol pumps and other works for clients such as Indian Railways (Southern Railways), Indian Oil Corporation Limited and Bharat Petroleum Corporation Limited, among others.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
