Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE D**' (read as **ACUITE D**) from the long-term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs. 14.00 crore bank facilities of The Star Cars Private Limited (TSPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

The rating is downgraded to '**ACUITE D**' on account of default of payment as per the publicly available information.

The Star Cars Private Limited, incorporated in the year 2011 is engaged in the authorized dealership of Volkswagen passenger cars. Non-cooperation by the issuer/borrower:
