Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B+**' (read as **ACUITE B plus**) from '**ACUITE BB-**' (read as **ACUITE double B Minus**)' on the Rs.12.00 crore bank facilities of Misquith Associates. This rating is now an indicative rating and is downgraded on account of information risk.

M/S Misquith Associates (Misquith) is a proprietary concern established in 2004 by Mr. Edward Misquith. It is located at Shirva, Udupi District (Karnataka). Misquith is engaged in developing residential as well as commercial projects in and around Udupi district and other parts of Karnataka.

Non-cooperation by the issuer/borrower

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
