# **Rating Rationale**

Acuité has reaffirmed the long-term rating of 'ACUITE D' (read as ACUITE D) on the Rs.14.00 crore bank facilities of Flourish Paper And Chemicals Limited (FPCL). The rating continues to be flagged as "Issue Not-Cooperating" and is based on the best available information.

# Non-cooperation by the issuer/borrower:
