Rating Rationale

Acuite has downgraded the long-term rating to 'ACUITE B+' (read as ACUITE B plus) from 'ACUITE BB-' (read as ACUITE double B minus) on the Rs. 10.00 crore bank facilities of Jalan Carbons and Chemicals Private Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Incorporated in 1995, Jalan Carbons and Chemicals Private Limited (JCCPL) is a West Bengal based company engaged in the manufacturing of coal tar pitch (CTP) and derivatives like creosote oils, naphthalene. They use coal tar as the raw material and distill it to produce naphthalene, oils of various grades and coal tar pitch. The company has its manufacturing unit one at Odisha and other at Jamshedpur with an installed production capacity of 24,000 MTPA for coal tar pitch and 19,000 MTPA for creosote oils. The company is promoted by Mr Ajay Jalan.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
