Rating Rationale

Acuité has reviewed the long term rating of '**ACUITE B+** (**read as ACUITE B plus**) on the Rs.8.09 Cr. bank facilities of Sundaram Poultry Farm (SPF). This rating is now an indicative rating based on the best available information.

About the company

SPF was originally established as a proprietorship firm in 2000 by Mr. T K Krishnamurthy. The firm was reconstituted as a partnership on October 1, 2018. Firm engaged in poultry farming of layer eggs. Mr. T K Krishnamurthy, Mr. G.K Shanmugasundaram, Mrs. S. Suganthi are the current partners of the firm. The facility is located at Maniyakarar Thottam, Dasapalayam, Annur Coimbatore, Tamil Nadu with 13 poultry sheds with a caging capacity of around 2,00,000 birds.

Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
