Rating Rationale

Acuité has reaffirmed the long term rating of 'ACUITE BB-' (read as ACUITE double B minus) to the Rs.20.00 crore bank facilities of Vintage Distillers Limited (VDL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Rajasthan based, Vintage Distillers Limited was incorporated in 1988. The company is engaged in manufacturing of country liquor and has diversified into manufacturing of whisky, vodka and rum in the past year. Its manufacturing facility is located at Alwar, Rajasthan. The manufacturing capacity for liquor is 56KL per day and bottling capacity is 20,000 cases per day. The company is promoted by Mr. Mohak Jain and Mr. Vinay Kumar Jain.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavored to gather information about the entity / industry from the public domain. Therefore, Acuité cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
