Rating Rationale

Acuite has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 50.00 crore bank facilities of Shree Balaji Tirupati Construction (SBTC) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Incorporated in the year 2003, Shree Balaji Tirupati Construction (SBTC) is an Agar-Madhya Pradesh based firm. The firm is promoted by Mr. Chandra Prakash Verma. The firm is engaged in the construction of roads and dams and selling of raw materials. The firm mainly work for PWD and Irrigation department of Madhya Pradesh.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
