# **Rating Rationale**

Acuité has downgraded the long-term rating to 'ACUITE BB' (read as ACUITE double Bf)rom 'ACUITE BB+' (read as ACUITE double B plus) and reaffirmed the short term rating of 'ACUITE A4+' (read as ACUITE A four plus) on the Rs.57.86 crore bank facilities of Shree Bholey Alloys Private Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

# About the Company

Incorporated in 2008 and promoted by Rakesh Kumar Singh and Satya Nand Singh, Shree Bholey Alloys Private Limited (SBAPL), is based in Jharkhand and engaged in manufacturing of silico manganese and has a plant situated at Bokaro operating at an installed capacity of 21560 MTPA. The company has significant presence at Northern and Western India and procures their primary raw materials from Manganese Ore India Limited (MOIL).

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
