## **Rating Rationale**

Acuité has downgraded the long-term rating to 'ACUITE B-' (read as ACUITE B minus) from 'ACUITE B' (read as ACUITE B) on the Rs.18.80 Crore bank facilities of Vedant Education Trust on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

### **About the Company**

Vedant Education Trust is a charitable trust set up in 2011 for promoting education. The trust has been set up by Mr. Bijinder Singh and Mr. Ashok Khurana and their sons, Mr. Yoginder Singh and Mr. Akshay Khurana, respectively. The trust is setting up a K-12 CBSE school in Greater Noida (Uttar Pradesh) under the name of The Shri Ram Universal School (TSUS), under a franchisee tie-up with SEL, which have promoted Sri Ram College of Commerce (SRCC) and Lady Shri Ram College (LSR) and have a long track record of operation in the education sector. The school is expected to start its operations in April 2021.

## **Unsupported Rating**

### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

### Limitation regarding information availability

This rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower). Acuite endeavoured to gather information about the entity/industry from the public domain. Any rating with the suffix 'Issuer not cooperating' is assigned without any management interaction with the issuer entity or any data / information from the entity. Sometimes this non co-operation by a

rated entity may be due to a result of deterioration in the credit risk profile of the entity. Therefore, Acuité cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
