Rating Rationale

Acuité has downgraded the long-term rating to '**ACUITE BB-**' (read as **ACUITE double B minus**) from '**ACUITE BB**' (read as **ACUITE double Ba**) and reaffirmed the short term rating of '**ACUITE A4+**' (read as **ACUITE A four Plus**) on the Rs. 6.00 crore bank facilities of Geo Engineering Company Private Limited (GECPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Incorporated in 1980, Geo Engineering Company Private Limited (GECPL) is promoted by Mr. Jayprakash and family. The company is engaged in geotechnical works such as executing earth work projects, soil and rock testing, piling, foundation and other consultancy services. GECPL undertakes work in Karnataka, Andhra Pradesh and Tamil Nadu.

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating.
