## Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE B-'(read as ACUITE B minus)** on the Rs.14.74 crore bank facilities of Kakda Rolling Mills. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

## About the Company

Bhopal based Kakda Rolling Mills (KRM) was set up in the year 1968 as a proprietorship concern by Mr. Deep Chandra Goel and later was converted into a partnership firm by Mr. Narendra K Goel and his three sons. The firm is primarily engaged in manufacturing of TMT bars and has its manufacturing facility located in Bhopal, Madhya Pradesh.

#### **Unsupported Rating**

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating.
