Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B+' (read as ACUITE B plus) on the Rs. 7.50 crore bank facilities of Rani Sati Trade and Finance Private Limited (RSTFPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Rani Sati Trade and Finance Private Limited (RSTFPL), incorporated in October 1998, is a West Bengal based company trading in Wheat and Maize. The company is promoted by Mr. Sandeep Kumar Maskara, Mr. Sanjeev Kumar Maskara and Manju Devi Maskara. The company operates in Dalkhola town in West Bengal. RTFPL majorly deals in maize and wheat which constituents around 80 to 90 per cent of its revenue. The company in addition to trading owns warehouse of 75,000 feet in Dalkhola for keeping its own goods.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating.
