Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 30.00 crore bank facilities of Goel Builders (GB). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Established as a partnership firm in 1990, Goel Builders (GB) engaged in developing of commercial properties based in Lucknow and manufacturing of concrete pipes. Currently, the firm has developed a mall in Lucknow named 'Crown Mall'. It has been leased out to Inox Leisure Limited, Shoppers Stop Limited, Spencers Retail Limited, Reliance Corporate IT Park Limited (Reliance Trends) along with other retail outlets. The firm is currently managed by Mr. Naresh Kumar Agarwal and Mr. Amit Agarwal.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
