Rating Rationale

Acuite has reaffirmed the long term rating of '**ACUITE BB-**' (read as **ACUITE double B minus**) on the Rs.10.00 crore bank facilities of Taashee Linux Services Private Limited (TLSPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Taashee Linux Services Private Limited (TLSPL) was established in 2008 as a partnership firm named as Taashee Linux Services by Mr. Abhishek Datt and Ms. M Nisha and is a technology and software services firm located in India with its Head Office located in Hyderabad and overseas location in Singapore. The company serves a wide range of customers by focusing upon multiple technologies and has formed strategic partnerships with software and I.T. giants like Red Hat, Microsoft, Google, Liferay, Alfresco, VMware, Enterprise DB, Amazon, Ubuntu, Nagios, Crafter, Lenovo, HPE, DELL and more.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain.
