Rating Rationale

Acuite has reaffirmed the long term rating of '**ACUITE BB-' (read as ACUITE double B minus)** on the Rs.10.00 crore bank facilities of Taashee Linux Services Private Limited (TLSPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.
