Rating Rationale

Acuite has downgraded the long-term rating to ‘**ACUITE B-**’ (read as **ACUITE B minus**) from ‘**ACUITE B**’ (read as **ACUITE B**) on the Rs. 7.20 crore bank facilities of Satyabhamadevi Bulchand Memorial Hospital Private Limited (SBMHPL) on account of information risk. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

Incorporated in 2019, Satyabhamadevi Bulchand Memorial Hospital Private Limited (SBMHPL) is an Ahmedabad based hospital whose operations started from January, 2020. The day to day operations is managed by its Chairman and Managing Director, Chanderlal Ambwani Bulchand, Managing Director, Rameshlal Ambwani Bulchand along with other directors, Dipak Rameshlal Ambwani who is B. Physio DPT and Sarla Jaikishan Ambwani who is BHMS. The hospital provides various facilities which collectively has a capacity of 70 beds.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.
