**Rating Rationale**

Acuité has reaffirmed the long-term rating to '**ACUITE D**' (**read as ACUITE D**) on the Rs. 432.66 Cr. Bank Facilities of AVIOM India Housing Finance Private Limited.

Acuité has reaffirmed the long-term rating to '**ACUITE D**' (**read as ACUITE D**) on the Rs. 201.50 Cr. Non-Convertible Debentures of AVIOM India Housing Finance Private Limited.

**Rationale for Rating:**

Acuite takes cognizance of the recent action by Reserve Bank of India (RBI) wherein it has superseded the board of directors of Aviom India Housing Finance Pvt Ltd and has filed an application for the insolvency resolution process under IBC. RBI has also appointed an Advisory Committee to advise the Administrator of Aviom India Housing Finance Private Limited. The members of the Advisory Committee are as follows: Shri Paritosh Tripathi, ex-CGM, State Bank of India, Shri Rajneesh Sharma, ex-CGM, Bank of Baroda and Shri Sanjaya Gupta, ex-MD & CEO, PNB Housing Finance Limited. The reaffirmation of the rating takes into account the lender feedback received, wherein additional lenders have notified that their exposures with the company are SMA-1, it also factors in the public notice by the company dated November 2024, disclosing discrepancies in the company's books of accounts, fraud within the company and liquidity constraints as mentioned in the press release dated November 28, 2024. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best information available.

**About the Company**

New Delhi Based, Aviom India Housing Finance Private Limited it was incorporated in 2016. The Company extends loans to women for home purchase and construction, home extension and improvement and loan against property. Currently Mr. Kunal Sikka, Ms. Kaajal Aijaz Ilmi, Mr. Sannovanda Machaiah Swathi, and Mr. Stephen Dongwon Lee are the directors of the company.

### **Non-cooperation by the issuer/borrower:**

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
