Acuité has reaffirmed its long term rating of 'ACUITE C' (read as ACUITE Ca)nd 'ACUITE D' (read as ACUITE D) and the short term rating of 'ACUITE D' (read as ACUITE Do)n the Rs.14.00 crore bank facilities of SLR Construction Private Limited. The rating continues to be flagged as "Issuer Not Cooperating" and is based on best available information.

About the Company

SLR Construction Private Limited (SLRCPL) was incorporated in 2006, by Mr. Shiv Kumar Bansal and his family, based in Delhi. The company is a class A civil contractor for CNG stations and buildings. Company is engaged into tender bases business where the company constructs work station/terminal in the pipeline project. All the projects are operated through GAIL (Gas Authority of India Limited), India's state-owned natural gas Processing and Distribution Company.

Non-cooperation by the issuer/borrower:
