Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) and short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs.9.77 Cr bank facilities of Quadssel Systems Private Limited (QSPL). The rating is flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Quadssel Systems Private Limited (QSPL) is a Chennai (Tamil nadu) based company which was incorporated in the year 1995 by Mr. Girish Madhavan. QSPL is engaged in the business of IT Infrastructure services, managed IT Services and Annual Maintenance Contracts (AMC) and other provides IT-related system integration solutions. Further, it is acting as a commission agent for selling computers and hardware software development.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
