Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE BB-**' (read as **ACUITE double B minus**) from '**ACUITE BB**' (read as **ACUITE double B**) on the Rs.15.91 Cr. bank facilities of Bharathi Homes And Realtors Private Limited (BHRPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Incorporated as a Proprietorship entity in 2008 as 'Bharathi Homes' and later re-constituted as a private limited company in 2016, Bharathi Homes And Realtors Private Limited(BHRPL) is a Chennai (Tamilnadu) based company. BHRPL is a residential real estate developer promoted by Mr. Arun Bharathi Arunachalam. BHRPL has completed about 18 projects in and around Chennai and developed around 1.50 lakh sqft area.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for
