Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) on the Rs 17.00 crore bank facilities of Srinath Weaving Mills LLP (SWM) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Srinath Weaving Mills LLP (SWM) was incorporated in Palladam of Tiruppur district in Tamil Nadu in the year 2017 and is currently promoted by Mr. Pawankumar Choudhary and Mr. Rajagopal Kumarasamy. The Firm is engaged in Manufacturing of Rayon filament fabrics, Grey fabric.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
