Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B+**' (read as **ACUITE B plus**) from '**ACUITE BB-**' (read as **ACUITE double B minus**) on the Rs. 7.87 Cr bank facilities of Kedar Metals Private Limited (KMPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Kedar Metals Private Limited (KMPL), incorporated in 1992, is engaged in the manufacturing of lead oxide and red lead which find application mainly in the traction batteries, submarine batteries, telecom batteries, ceramics and glass industry. The company has its manufacturing facility at Daman. KMPL is a part of the Kedar Group, which includes two other companies - Kailash Metachem Private Limited (Kailash) and Bliss International Private Limited (BIPL). The Director of the company is Mr. Jitesh Muni.

Unsupported Rating

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
