Rating Rationale

Acuite has downgraded the long-term rating to ‘**ACUITE B-**’ (read as **ACUITE B minus**) from ‘**ACUITE B**’ (read as **ACUITE B**) on the Rs.5.00 crore bank facilities of Creative fibrotech on account of information risk. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

Creative Fibrotech was established in the year 2012. The firm is promoted and managed by Mr. Pankaj Shyam Chawla. The firm is engaged in manufacturing and export of FRP products. Automobile, electronics & electrical and allied engineering related industries are some of sectors where the offered FRP products find wide applications. The firm is based out of Pune, Maharashtra. The firm also exports its product to Dubai, U.K and Kuwait.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
