Rating Rationale

Acuite has reaffirmed the long term Issuer Rating (IR) of '**ACUITE BB+**' (read as **ACUITE double B plus**) of AISECT Limited (AL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Bhopal based AISECT Limited (AL) was incorporated in 2006 by Mr. Siddharth Chaturvedi and Mr. Santosh Choubey. The company is majorly engaged in providing various services such as banking services, management services, general supplies, selling of educational books and also provides coaching and skill training to various aspirants. The company is a part of the AISECT group which is the country's leading social enterprise working in the areas of skill development, higher education and other technology based services.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain.
