Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B+' (read as ACUITE B plus) from 'ACUITE BB-' (read as ACUITE double B minus) on the Rs. 99.00 crore bank facilities of B Square Developers (BSD) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

B Square Developers, established on 7th January 2019, is a partnership firm to develop Karnavati Agriculture Market Yard in Ahmedabad with the objective of developing, operating, and maintaining APMC. They are developing this market to facilitate, coordinate and promote the marketing and trading activities of the farmers in agricultural and other commodities, articles, and goods. Partners of B Square Developers are Mr. Bipinbhai Naranbhai Patel, Mr. Dhruv Bipinbhai Patel, Mr. Lalitkumar Babubhai Patel and Mr. Vaibhav Babubhai Patel.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
