The Company is based at Bhosari, Pune, and Maharashtra. Global Tools is engaged in manufacturing and regrinding of all types of Cutting tools, H.S.S and Carbides Tools which is used in specialize Vertical Milling Machines (VMC), CNC and Metal Cutting Machines.

**Non-cooperation by the issuer/borrower:**

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
