Rating Rationale

Acuite has reaffirmed the long-term rating of 'ACUITE D' (read as ACUITE Do) on the Rs. 13.84 crore bank facilities of Khator Technical Textiles Private Limited (KTTPL). The rating continues to be flagged as “Issuer Not Co-operating” and is based on the best available information.

About the Company

Khator Technical Textiles Private Limited (KTTPL), incorporated in 2013, is a Silvassa-based company promoted by Mr. Kailash Khator and Mr. Amit Khator. The company is engaged in the manufacture of geotextiles and commenced commercial operations in February 2014.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
