# **Rating Rationale**

Acuité has reaffirmed the short term rating of **'ACUITE A4'** (**read as ACUITE A four**) on the Rs. 6.50 crore bank facilities of Kisha Telelinks Private Limited (Previously Name KGR Telelink Private Limited). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

### About the Company

Kisha Telelinks Private Limited (Previously Name KGR Telelink Private Limited) incorporated in 2004 is a Mumbai based company engaged in trading of mobile handsets and accessories. The company exports mobile handsets and accessories to Dubai and Hong Kong. Further, Kisha Telelinks Private Limited is also engaged as a distributor of Micromax, Vivo and Reliance Jio handsets in Goa. Its directors are Mr. Kailash Prakash Karamchandani, Ms. Bharti Prakash Karamchandani and Ms. Rhea Kailash Karamchandani.

### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating.
