Rating Rationale

Acuité has downgraded the long-term rating to '**ACUITE B+**' (read as **ACUITE B plus**) from '**ACUITE BB-**' (read as **ACUITE double B minus**) and the short term rating to '**ACUITE A4**' (read as **ACUITE A four**) from '**ACUITE A4+**' (read as **ACUITE A four plus**) on the Rs. 35.00 crore bank facilities of Jainco Buildcon Private Limited (Erstwhile Jainco Buildcon Limited) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Jainco Buildcon Private Limited (Erstwhile Jainco Buildcon Limited), incorporated in 2006, is a Delhi based civil contractor that has executed civil construction projects for government entities such as Delhi Jal board (DJB) and Public Health Engineering Department, among others. The operations are managed by Mr. Naresh Jain and Mr. Yatin Jain.
