#### **Rating Rationale**

Acuité has downgraded the short-term rating to 'ACUITE A4' (read as ACUITE A four) from 'ACUITE A4+' (read as ACUITE A four plus) on the Rs. 6.00 Cr. bank facilities of Deekay Electricals (DK), Bangalore on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.
