Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) on the Rs. 5.00 crore bank facilities of Middleton Supply Chain Private Limited (Erstwhile Decorazzi Paints Private Limited). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Middleton Supply Chain Private Limited (Erstwhile Decorazzi Paints Private Limited) was established in 2014. Mr. Nikhil Gupta, Mr. Rahul Mehra, Mr. Kaavya Gupta are directors of the company. The company is engaged in the manufacturing and marketing of decorative paints. The registered office is located at Kolkata.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower).
