Rating Rationale

Acuité has reaffirmed the long-term rating of ‘**ACUITE D**’ (read as **ACUITE Do**) n the Rs. 8.50 crore bank facilities of R S Travel and Tours India Private Limited. The rating continues to be flagged as “Issuer Not Cooperating” and is based on the best available information.

About the Company

New Delhi-based company, R S Travel and Tours India Private Limited was incorporated in 2007 by Mr. Krishan Kumar Jain and Mrs. Nisha Jain. The company is an authorized IATA (International Air Transport Association) agent, books travel tickets apart from offering holiday packages and providing visa processing services.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
