**Rating Rationale**

Acuite has downgraded its long-term rating to '**ACUITE C**' (read as **ACUITE C**) from '**ACUITE B+**' (read as **ACUITE B plus**) and the reaffirmed the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) of the Rs. 35.00 Cr. bank facilities of Salvi Chemical Industries Limited. (SCIL).

This rating continues to be flagged as issuer not cooperating on account of information risk and is based on best available information.

"The downgrade is based on information reflected in the Credit Information Company (CIC) report, which reflects delays in repayment of property loan in the month of August 2024.

**About the Company**

Incorporated in 2005, Mumbai based Salvi Chemical Industries Limited (SCIL), is a manufacturer and exporter of chemical and pharmaceutical products including ferrous fumarate, cellulose acetate phthalate etc. The directors of the firm are Mr. Kantilal Narandas Salvi, Mr. Nirav Kantilal Salvi, Mr. Kaushal Kantilal Salvi, Mr. Vijay Jayantilal Thaker, Mr. Vipul Amul Desai and Ms. Shweta Kaushal Salvi.

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

**Limitation regarding information availability**

This rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower). Acuite endeavoured to gather information about the entity/industry from the public domain. Any rating with the suffix 'Issuer not cooperating' is assigned without any management interaction with the issuer entity or any data / information from the entity. Sometimes this non co-operation by a rated entity may be due to a result of deterioration in the credit risk profile of the entity.
