Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE D' (read as ACUITE D) on the Rs. 9.66 crore bank facilities of Latha Educational Society. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Latha Educational Society (LES) is a Tamil Nadu based trust established in 1993 by the Late Mr. Chinnasamy and Mr. Murugan. The trust runs Sakthi Matric Higher Secondary School at Chinnasalem, Tamil Nadu.

Non-cooperation by the issuer/borrower:
