Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B+' (read as ACUITE B plus) and short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 7.75 crore bank facilities of ARASU AUTOS THANJAVUR (AAT). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Arasu Auto (Thanjavur) was established in the year 1990 and is engaged in 2W dealership of Bajaj Auto in Thanjavur under the brand name Arasu Bajaj. The operations of the firm are managed by Mr. R.Thirunavukkarasu, Managing Partner who has over two decades of experience in this line of business. Arasu Auto (Thanjavur) has around 15 branches for two wheelers across Thanjavur and is the sole dealer for Bajaj Auto Limited in this region.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavored to gather information about the entity/industry from the public domain. Therefore, Acuité cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
