#### **Rating Rationale**

Acuité has downgraded its long-term rating to 'ACUITE BB' (read as ACUITE Double Bf)rom 'ACUITE BB+' (read as ACUITE Double B plus) and reaffirmed its short-term rating of 'ACUITE A4+' (read as ACUITE A four plus) on the Rs.37.50 Cr. bank facilities of N R Constructions (NRC). The rating is now flagged as "Issuer Not-Cooperating" and is based on the best available information. The rating is downgraded on account of information risk.

Based in Hyderabad, N R Constructions is a partnership firm incorporated in 1998. The company is engaged in the civil construction business. #### Non-cooperation by the issuer/borrower
