Rating Rationale

Acuité has reaffirmed the long term rating of 'ACUITE B+' (read as ACUITE B plus) and the short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs.5.00 Crore bank facilities of VTC Transport Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

VTC transport private limited was established in 1997 and promoted by Mr. Akshay Verma. The company is engaged in handling and transportation of heavy machinery and valuable consignments like iron and steel coils, channels, cement, coal, etc. the branch offices of the company are located at New Delhi, Chandigarh, Ludhiana and Jalandhar, Unchahar, Panipat, Kullu, Aligarh(U.P). Recently, the Company have also started trading and distribution business for "Cello".

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating.
