Rating Rationale

Acuité has reaffirmed the long-term rating of ‘**ACUITE D**’ (read as **ACUITE D**) and the short-term rating of ‘**ACUITE D**’ (read as **ACUITE D**) on the Rs.6.40 crore bank facilities of Sitara Conductors And Cables Private Limited (SCCPL). The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

Sitara Conductors and Cables Private Limited (SCPL), a West Bengal based company was established in 1986 as a proprietorship firm and changed to private limited in 2007. The company, led by Directors, Mr. Nirmal Kumar Mukim and Mrs. Alka Devi Mukim, is engaged in the manufacture of aluminium conductors and cables used for power distribution. The day-to-day operations are managed by Mr. Nirmal Kumar Mukim.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
