Rating Rationale

Acuite has downgraded the long-term rating to 'ACUITE B-' (read as ACUITE B minus) from 'ACUITE B' (read as ACUITE B) and reaffirmed the short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs.10.00 crore bank facilities of Sarjan Watertech India Private Limited (SWIPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Ahmedabad based, Sarjan Watertech India Private Limited (SWIPL) was established as a proprietorship firm in 2003 and later changed the constitution into a private limited company in 2008. The company is promoted by Mr. Sunil Trivedi and his family. SWIPL is an ISO: 9001-2015 certified company that manufactures, assembles, supplies and exports water purification and treatment systems and allied accessories for domestic, commercial and industrial use. Also, the company has BIS -14724 and BIS-16240 certifications in UV water purifier and RO water purifier, respectively.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability

Acuite endeavoured to gather information about the entity/industry from the public domain.
