Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 7.52 crore bank facilities of Multimech Engineers (ME). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Established in 2006, Multimech Engineers (ME) is a proprietorship firm based out of Coimbatore in Tamil Nadu, engaged in manufacturing and fabrication of pressure vessels, material handling equipment and air volume tanks. The firm is promoted by Mr. Sivakumar.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
