Rating Rationale

Acuité has downgraded the long-term rating to '**ACUITE B-**' (read as **ACUITE B minus**) from '**ACUITE B**' (read as **ACUITE B**) and reaffirmed the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 7.52 crore bank facilities of Multimech Engineers (ME) on account of information risk. The rating continues to be flagged as "Issuer Not Cooperating" and is based on best available information.

About the Company

Established in 2006, Multimech Engineers (ME) is a proprietorship firm based in Coimbatore in Tamil Nadu, engaged in manufacturing and fabrication of pressure vessels, material handling equipment and air volume tanks. The firm is promoted by Mr. Sivakumar.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

gather information about the entity/industry from the public domain.
